# **EXPORT PROMOTION ACTIVITIES 2021-22**

The Export Promotion activities particularly in respect of organizing in-person events (Physical events) during the financial Year 2021-22 was largely affected by the COVID-19 pandemic situation prevalent across the world.

However, the year witnessed many virtual events being organised by established event organizers. Further, as a measure to provide marketing opportunities for its member exporters, Council also organized its own virtual events on a customized virtual platform targeting different market regions around the world.

The details of virtual / physical events participation organised by the Council during 2021-22 are furnished below:

### **Virtual Events Abroad:**

# 1. Home Textiles Sourcing Expo, New York, USA (20-22, July 2021)- Virtual

Council participated in the virtual edition of Home Textiles Sourcing Expo (HTSE) New York, USA during 20-22 July 2021. The event was organised on Self-sustained basis.

Due to the pandemic situation, this virtual event had a participation of two member exporters through HEPC.

As per the feedback of participants, the event had 92 visitors who were mainly from USA. The participants also had some visitors from South Africa, Germany, etc and also few buying agents from India. The participants had 14 virtual meetings with some of the buyers who virtually visited their stalls. Business enquiries generated during this virtual event is Rs.0.12 crore.

# 2. India Textiles Sourcing Fair Coinciding National Handloom Day (7-13, August 2021)-Virtual

The export basket of Indian handwoven products constitutes around 85% of home textiles, 10% fabrics and 5% of clothing accessories. Traditional handwoven products such as Sarees, dhoties and lunghies grouped under fabrics product segment have been witnessing a decline in exports in recent time. As a measure to enhance export of these traditional textiles, Council organised the Indian Textiles Sourcing Fair on its Virtual platform with specific focus on traditional textiles of India namely Sarees, Dhoties, Lungies, Stoles, Scarves & Shawls and other accessories, Garments, Dress materials and fabrics, Carpets, etc. The virtual event was organized to show case Traditional Textiles of India coinciding with the National Handloom Day- August 7th. Initially, the event was scheduled from August 7-11, 2021, however, based on feedback received from exhibitors and buyers the event was extended up to August 13, 2021.

For this edition of ITSF, importers of above-mentioned traditional products from Sri Lanka, Nepal, Bhutan, Bangladesh, Myanmar, Malaysia and Singapore were targeted since these countries have a sizeable population of Indian Diaspora and population who have demand for these products. The Indian Mission Posts at Bangladesh, Malaysia, Nepal, Singapore, Sri Lanka, Bhutan and Myanmar ably supported the virtual event by providing necessary assistance by sharing the details of potential visitors and contact details of Chambers of Commerce/Trade associations.

57 Indian companies comprising mixed group of Exporters, Cooperatives, Clusters, Master Weavers, India Handloom Brand holders, National Awardees, Producer companies Artisans, Trust, State Apex Corporations/Apex Societies etc participated in this edition of ITSF. The virtual event had participation from 20 states from all over India.

The various products displayed by participants at the virtual fair include Kanjivaram silk sarees and Wedding bridal sarees; Benaras silk sarees and dress materials, handwoven and handspun sustainable and ethical textiles; handwoven fabric, Stole, Scarve, Shawl, Tie, Waree, Dhoti, Home furnishing (Cushion covers) etc. made of Muga, Eri and Mulberry silk; products depicting Assamese traditions like Mekhela, Chaddhar, Sarees, Indo Western dresses etc.

ITSF 2021 received overwhelming response thus resulting in 214 visitor registrations, of which 83 had virtually logged in during the event. An exclusive exhibitor's directory was developed as an e-catalogue and circulated among the buyers and made available for downloading from the event platform. Participants profile was also circulated among the registered trade visitors and prefixed one-on-one virtual meetings (130 Nos) as per the choice of visitors were organised by the Council.

As per the feedback received from participants, spot orders of Rs.0.15 crore and business enquiries worth Rs.14.50 crore were generated from ITSF 2021 virtual event.

The virtual event was organised as per the Annual Marketing plan under National Handloom Development Programme of O/o. Development Commissioner (Handlooms), Ministry of Textiles, Govt.of India.

3. All Fashion Sourcing, Cape Town, South Africa (19-21 Oct. 2021)- Virtual

Council participated in the virtual edition of All Fashion Sourcing during 19-21 October 2021, Cape Town, South Africa. The event was organised on Self-sustained basis.

Organised by Messe Frankfurt South Africa this Covid-19 compliant immersive event was hosted live and online. The event featured both local and international products at the pop-up showroom and exhibited virtually by South African textile, leather, footwear and fashion manufacturers. A major focus was on sustainability, trend talks, localisation and fashion shows.

The virtual event was attended by Buyer, Clothing Manufacturer, Import/Export Agent, Marketing Manager, Sales Rep, CEO, Fashion Designer, Managing Director, Media, Sourcing Manager. The next edition will be held from 26-28 September 2022.

During the 3-day virtual event HEPC's participants of 2 member exporters were able to attract 15 virtual visitors, they were able to generate trade enquiries worth Rs.0.20 crore.

# 4. Buyer Seller Meet, Brazil (18-19 Nov 2021) - Virtual

The Consulate General of India, Sao Paulo and HEPC jointly organised the Home Décor-Brazil, 18-19 Nov.'2021 on the virtual platform of the Consul General of India successfully. The event as a Buyer Seller Meet was organised on Self-sustained basis.

The event had a digital inaugural address from Shri.Amit Kumar Mishra, Consul General of India in Sao Paulo, Shri T.V.Chandrasekaran, Chairman, HEPC and also statements from ABcasa and SInditecidos

The Consulate General of India, Sao Paulo, rendered their valuable support in finalising Hotmarketing, Brazil as the agency for co-ordinating and organising the event and partly sharing the organising cost. Further, the Consulate General of India in Sao Paulo also made necessary interpretation arrangements by hiring interpreter services.

The virtual Buyer Seller Meet (VBSM) with a focus on Brazilian importers, was organised as a 2-day virtual Buyer Seller Meet which had the participation of 15 Indian exporters and 19 Brazilian buyers. A total of 155 B2B virtual meetings were organized.

As per feedback of participants, trade enquiries worth Rs.1.40 crore and spot orders worth Rs.0.30 crore were generated during the 2 days virtual event.

# 5. Dubai Expo 2020, UAE (26th Nov. to 2nd Dec. 2021)- Physical

World Expo is organised once every five years by the Bureau des Expositions (BIS) and has been widely recognised as one of the most important platforms for the countries to showcase their achievement, capabilities, and economic prowess at the global level. The Department of Commerce, Government of India as the nodal agency to coordinate India's participation and Federation of Indian Chamber of Commerce & Industry (FICCI) as a lead Industry partner were effectively involved in organising India Pavilion participation at World Expo 2020, Dubai, the world's largest business summit held from 1st October 2021 to 31st March 2022,in Dubai to celebrate humanity's resilience, creativity, culture and innovation to create a new world in the post-pandemic era.

Handloom Export Promotion Council (HEPC) undertook sector-specific promotion activity by screening an AV film on a digital screen at India Pavilion exclusively hired by the Council. Screening of promotional videos specially prepared for the event was undertaken by the Council in India Pavilion during 26th November 2021 to 2nd December 2021 which was earmarked for the Textiles sector and was viewed by visitors

from all over the world. Further, the event also had the visit of large number of Indian Diaspora from the Gulf region.

The Textile Sector pavilion was inaugurated by Shri Vijoy Kumar Singh, Additional Secretary, Ministry of Textiles in the presence of Shri.Jay Karan Singh, Trade Advisor, Ministry of Textiles, Officials from Indian Consulate in Dubai, Chairmen and Executive Directors of participant EPCs.

Further to the inauguration, an interactive session on "India the sourcing destination for Textiles – PLI scheme a game changer" was held and the meeting was chaired by Shri.Vijoy Kumar Singh and attended by Shri. Jay Karan Singh, Trade Advisor, Dr.Gunveena Chadha, Assistant Secretary General, FICCI, Shri. K.Kalimuthu, Consul (Trade, Commerce & Economic), Consulate General of India. Speaking on the occasion, the Chairman highlighted HEPC activities and potential of Indian handloom sector.

On the second day of the event, there was a meeting organised at the Oberoi Hotel on "India preferred sourcing partner for Textiles & Clothing" at Hotel Oberoi" the meeting was chaired by Shri Vijoy Kumar Singh and attended by Dr.Aman Puri, Consul General of India, Shri. Jay Karan Singh, Trade Advisor, Representatives of various trade Association sand Chairmen & Executive Directors of various textile EPCs. The Chairman, HEPC delivered his speech highlighting the potential of handloom sector and various products being exported by the members of the Council.

On the third day, the delegation members visited International Apparel & Textile Fair (IATF) held at World Trade Centre and had a B2 B meeting with the participants of Bangladesh, Sri Lanka, The Chairman, Vice Chairman, & The Executive Director of the Council had a meeting with some of the exhibitors from these countries.

Dubai with its strategic location and a better global connectivity is emerging as an important business hub and as a gateway for the growth of markets in Middle East, Africa and South Asia As FTA with UAE has been signed, it is the right time that our member exporters avail the market potential by way of their active participation in every available opportunity in Dubai.

### 6. Buyer Seller Meet, Dubai, UAE (3-15 Jan. 2022) )-Virtual

Council participated in the virtual event of BSM, Dubai, UAE during 3-15 January 2022 organised by Director General of Foreign Trade. The event as a Buyer Seller Meet was organised on Self-sustained basis.

This virtual event had a participation of 33 member exporters through HEPC.

# 7. Indian Handwoven and Hometextiles Sourcing, Japan (8-10, Feb. 2022) )-Virtual

HEPC organised the Indian Handwoven & Hometextiles Sourcing (IHHS), Japan during 8-10 February 2022 on the virtual platform. The event was organised for the second time in succession during these 2 years of pandemic period.

The event was inaugurated with a welcome address delivered by Shri.T.V.Chandrasekaran, Chairman, HEPC and the inaugural address by H.E.Sanjay Kumar Verma, Ambassador of India, Embassy of India, Japan.

A total of 150 pre-fixed virtual meetings with Japanese buyers were organised for the Exhibitors. Such pre-fixed meetings were also facilitated with language interpreter services organised by the Council for a simultaneous interpretation of interaction between the buyer and seller on online platform.

The event had the participation of 19 exhibitors from across the country and 48 registered visitors. The event fetched trade enquiries worth Rs.0.87 crore and spot orders Rs.0.01 crore during the 3 days virtual event. However, many participants were very optimistic in securing orders from the buyers in due course of time.

The event as a Buyer Seller Meet was organised under National Handloom Development Programme of O/o.The Development Commissioner (Handlooms), Ministry of Textiles, Government of India.

# 8. Indian Handwoven and Hometextiles Sourcing, Germany & Belgium (14-16, Feb. 2022)-Virtual

HEPC organised the Indian Handwoven & Hometextiles Sourcing (IHHS), Germany & Belgium from 14-16 February 2022 on the virtual platform.

The event was inaugurated with a welcome address by Shri.T.V.Chandrasekaran, Chairman, HEPC, H.E. Mr. Santosh Jha, Ambassador of India to Belgium and Mr. Gaurav Sharma, First Secretary (Economic & Commercial), Embassy of India, Berlin delivered the inaugural address on 14/02/2022.

Council closely coordinated with Embassy of India in Berlin, Indian Consulates in Frankfurt, Hamburg and Embassy of India in Brussels through a series of virtual meetings towards mobilising registration and visit of buyers from this region. Based on suggestions from the Embassy of India in Berlin, S.N.Publishing House in Germany rendered their services in publicising the information about our virtual event through their digital publications.

The event had the participation of 22 exhibitors from across the country and 73 registered trade visitors from the target countries. A total of 85 pre-fixed virtual meetings with the buyers were organised for the Exhibitors.

As per the feedback received from participants, the event fetched trade enquiries worth Rs.0.50 crore and spot orders Rs.0.21 crore during the 3 days virtual event. However, many participants were very optimistic in securing orders from the buyers in due course of time.

The event as a Buyer Seller Meet was organised under National Handloom Development Programme of O/o The Development Commissioner (Handlooms), Ministry of Textiles, Government of India.

# Indian Handwoven and Hometextiles Sourcing, Sweden & Denmark (2-4 March 2022)-Virtual

HEPC organised the Indian Handwoven & Hometextiles Sourcing (IHHS), Sweden & Denmark during 2-4 March 2022 on the virtual platform.

The Council had coordinated with series of virtual meetings involving the officials of the Commercial section of the Indian Embassies in Sweden & Denmark. Indian Mission in both the Countries rendered their valuable support by sharing the buyer database, social media promotions and finalizing the agency for buyer mobilisation. Based on the suggestions from Embassy of India in Denmark, the Council availed the services of Harbinger Public Relations a renowned agency from Denmark for buyer mobilisation and arrangement of pre-fixed virtual meetings with potential buyers from Sweden and Denmark for the Exhibitors. The agency had undertaken print and social media campaign and telemarketing to register the buyer for event participation

Exhibitors were imparted training on the virtual platform and were thoroughly explained about the various tools and features of the virtual platform and were guided on

boarding onto the virtual platform and virtual meeting. A preview presentation was also made to the registered buyers to help them in understanding the profile of exhibitors and in navigating virtual platform

The event had the participation of 20 exhibitors across the country and 63 registered visitors and over 25 prefixed meetings. The event had an impressive number of one-on-one virtual meetings, which fetched business enquiries worth Rs.1.29 crore during the 3 days virtual event.

The event as a Buyer Seller Meet was organised under National Handloom Development Programme of O/o.The Development Commissioner (Handlooms), Ministry of Textiles, Govt. of India.

# 11. Indian Handwoven and Hometextiles Sourcing, UK (15-17 March 2022)- Virtual

Exhibitors were imparted training on the virtual platform and were thoroughly explained about the various tools and features of the virtual platform and were guided on boarding onto the virtual platform and virtual meeting. A preview presentation was also made to the registered buyers to help them in understanding the profile of exhibitors and in navigating virtual platform.

The event was inaugurated with a Welcome address delivered by Shri.T.V.Chandrasekaran, Chairman, HEPC and the inaugural address by Shri.Rohit Vadhwana, First Secretary (Economic and Press & Information), High Commission of India, UK.

The event had the participation of 20 exhibitors across the country and 77 registered visitors and over 51 prefixed meetings. The event had an impressive number of one-on-one virtual meetings, which fetched Trade enquiries worth Rs.0.71 crore and Spot orders Rs.0.16 crore during the 3 days virtual event.

The event was organised under National Handloom Development Programme of O/o.The Development Commissioner (Handlooms), Ministry of Textiles, Government of India.

# 12. Handloom Sourcing Expo at Guwahati, Assam (22–24 March 2022)- Physical

The Handloom products of the North East region (NER) are most colourful and unique in traditional design and pattern which attract the buyers. The products of Arunachal Pradesh get recognized across the globe for their exceptional designs and intrinsic

organic materials used for weaving various apparel. Assam is home to exclusive silks, including the most striking and prestigious— Muga, the invention of Assamese weavers, symbolizes the life and culture of Assam. Design and color contribute the necessary adjuncts for the marketability of the product of the region. For instance, certain designs like "Tenguoupal", 'Chang', Tangkhul' etc. from Manipur and Nagaland attract the attention of foreign buyers. Tribal women of Tripura generally produce the fabric for their requirements in their own loin loom. The Manipuri woman also produces a fabric in their homes in loin looms for their use. The weavers of Tripura produce a lot variety of fabrics Rignai/Saree/Dhoties/Lungies etc.

In consideration of the market potential of handwoven products of this region, Ministry of Textiles, Government of India has been emphasizing the need for focusing market development of this region. To align with these objectives of Ministry of Textiles, Govt. of India, Handloom Export Promotion Council organized a special Handloom Sourcing Show (HSS) an Exclusive Sourcing Event for the North Eastern Region Product at Vivanta Guwahati, in Joy Sagar Hall during 22nd to 24th March 2022. The event was organised with an objective to provide necessary market linkage for International market for the handwoven products from NER.

The Sourcing Show was inaugurated by the Chief Guest Shri.Vijayendra, IAS, Additional Chief Secretary- Handloom, Textiles & Sericulture and Welfare of Minorities & Development Departments to Government of Assam with an inaugural address followed by a ribbon cutting in the presence Shri.P.Gopalakrishnan, Vice Chairman, HEPC, Brig(Retd) Shri.R.K.Singh, Managing Director, NEHHDC, Shri.S.Bandyopadhyay, Director, WSC, Guwahati, Shri N. Sreedhar, Executive Director, HEPC, Buyers, Trade Visitors, Participants, Govt. Officials press & media. The Chief guest also released the Show directory brought out by the Council exclusively for the event.

50 exhibitors from Assam, Manipur, Tripura, Meghalaya, Mizoram, Arunachal Pradesh & Nagaland participated in the event, which was organized predominantly as a B2B event inviting trade visitors from other regions of the Council and neighboring countries. About 47 Trade visitors visited the fair which included foreign buyers, trade visitors from other regions of the Country. The event also had 380 general visitors.

As per the feedback of the participants, a spot order/sale of handloom products worth of Rs.0.52 crore & enquiries worth of Rs.4.19 crore was reported. A total business of Rs.4.71 crore was generated during the 3 days event.

The event was organised with the financial assistance under National Handloom Development Programme of O/o. Development Commissioner (Handlooms), Ministry of Textiles, Govt. of India.

# 13. Global Sources Online, Hong Kong (20/02/2022 to 31/03/2022)- Virtual

Council identified a virtual platform of Global Sources, which is an internationally recognized B2B sourcing platform. Global sources online is a B2B virtual trade event

organised by Global sources Hong Kong – a firm known for organising trade shows and publishing for many years The company connects authentic buyers and verified suppliers worldwide with tailored solutions and market intelligence through trade shows, digital platforms and magazines.

In this e-commerce platform HEPC organised virtual participation for 10 member exporters under Global Sources Lifestyle & Fashion, Home & kitchen categories from 20th February to 31st March 2022.

Council's exporters have reported that they have received a good footfall of visitors numbering around 200 visitors related to their products and the event as an online platform had generated good business turnover. The event participation drew trade enquiries worth Rs.0.51 crore and spot order worth Rs.0.54 crore during the virtual event. With the online presence being extended, the participants are very optimistic in securing orders from the buyers in due course of time as the webpage of each participant will be live for global visitors/buyers through-out this year.

The event was organised under Market Access Initiative scheme of the Ministry of Commerce & Industry, Govt. of India, New Delhi.

Development Commissioner (Handlooms), Ministry of Textiles, Govt. of India.

The exhibition was inaugurated by Shri.Upendra Prasad Singh, IAS, Secretary, Ministry of Textiles, Government of India, by ribbon cutting & lightening of lamp in the presence Shri.Sanjay Rastogi, IAS., Development Commissioner for Handlooms, Shri.T.V.Chandrasekaran, Chairman, HEPC, Ministry Officials, Executive Director, HEPC, participants, press & media.

22 exhibitors displayed their exclusive Handwoven products such as Sarees, Dress materials, Stoles, Scarves, Shawls, Dhoties, Lunghies, Carpets etc. The event is the first of its kind organised by HEPC for the domestic market as an in-person B2C event after the Corona pandemic outbreak.

During the visit, the Secretary (Textiles) accompanied by the Development Commissioner (Handlooms) interacted with each individual exhibitor and ascertained the details such as their product ranges and its marketability etc.

The participants expressed satisfaction on visitor turnout and also sales achieved in sizeable quantities. Over 500 visitors visited the event during 6 days. The visitors purchased traditional & contemporary Handloom products alike.

As per feedback of the participants, a spot sale of their handloom products worth of Rs.0.19 crore and enquiry worth of Rs.0.08 crore was reported. A total business Rs. Rs.0.27 crore was generated during the 6 days through a good number of visitors who visited their stalls.

As per feedback of the participants, a spot sale of their handloom products worth Rs.0.04 crore and enquiry worth Rs.0.009 crore was reported. A total business Rs.0.049 crore was generated during the event.

### 3. India International Trade Fair, New Delhi (14-27 November 2021)- Physical

Handloom Export Promotion Council (HEPC) has been nominated as the implementing agency by Office of the Development Commissioner for Handlooms (DCH), Ministry of Textiles for participation of 42 National Awardees, Producer Companies, Cooperatives and Weaver entrepreneurs selected by the  $\rm O/o$  the DCH and 8 member exporters of the Council.

Against this, due to unavoidable reasons 4 weavers were unable to participate.. 38 National Awardees, Producer Companies, Cooperatives and Weaver entrepreneurs and 8 member exporters displayed their exclusive Handwoven products such as Sarees, Dress materials, Stoles, Scarves, Shawls, Dhoties, Lunghies, Carpets etc.

As per feedback of participants, over 54,461 visitors including 51,774 end users and 2,687 business visitors visited participants stands during show days. Spot sales of Rs.1.23

crore and business enquire worth of Rs.2.49 crore was generated during the event as reported by the participants. A total business of Rs.3.72 crore was generated during the 14 days through a good number of visitors who visited their stalls.

The event participation was organised availing financial assistance under National Handloom Development Programme of O/o. Development Commissioner (Handlooms), Ministry of Textiles, Government of India.

The Trade Fair witnessed over 8000 Virtual booth visits by the business delegates, which led to over 2500 business interactions. Also, the virtual exhibition platform witnessed over 3000 Business card exchanges and had representation from varied sectors from the BRICS member countries, with 610 exhibitors from the five countries.

HEPC participated in the event with a participation of 9 member exporters.

The webinar event started with a welcome address by Shri.N.Sreedhar, Executive Director and was followed by a presentation from Ms. Irene Vermeulen.

Over 25 member exporters participated in the live Webinar and handouts were provided to all the participants. All the participants were extremely happy to attend the seminar and opined that it was really useful.

### 6. Tamil Nadu Investors' Meet at Coimbatore-Physical

As a measure to provide inputs on above parameters, HEPC availed the services of Ms.Irene Vermeulen, a design and marketing consultant and founder of Craftscurator.com to host a live interactive workshop titled 'Your opportunities in the European Market' on Thursday December 16, 2021

The webinar event started with a welcome address by Shri.N.Sreedhar, Executive Director and was followed by a presentation from Ms. Irene.

Over 25 member exporters from the states Assam, Bihar, Haryana, Kerala, Maharashtra, Punjab, Tamil Nadu & Uttar Pradesh, participated in the live workshop Webinar and handouts were provided to all the participants.

All the participants expressed their satisfaction on the initiative of HEPC to organise such a webinar, which they felt was really useful. During the workshop, several surveys were conducted with an active participation from the participants.

- 5. - 6. Council has organised webinar on the topic "online export bill regularisation" organised by the HEPC in coordination with ICICI bank through video conference on pan Indian basis held on 30th July 2021. During webinar, the information on documents required for exports like regulatory documents, commercial documents and transport documents & regulatory bodies in exports, important regulation for exporters, to handle the issues faced in export bill regularization and available assistance has been disseminated. The webinar was attended by 45 member exporters.

7. Council organised a seminar "Identifying and Handholding Exportable Products at Warangal, Telangana" at Prataparudra hall, Haritha Kakatiya, Nakkalgutta, Hanamkonda on October 28th, 2021 with financial grant under the National Handloom Development Programme (NHDP) scheme of the Office of the Development Commissioner (Handlooms), Ministry of Textiles, Govt. of India. # Management's Responsibility for the Standalone Financial Statements

The Company's Committee of Administration is responsible for the matters stated in section 134(5) of the Act with respect to the preparation of these standalone financial statements that give a true and fair view of the financial position, financial performance, total comprehensive income and cash flows of the Company in accordance with the Ind AS and other accounting principles generally accepted in India. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the standalone financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the standalone financial statements, management is responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

The Company's Committee of Administration is responsible for overseeing the Company's financial reporting process.

### Auditor's Responsibilities for the Audit of the Standalone Financial Statements

Our objectives are to obtain reasonable assurance about whether the standalone financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with SAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these standalone financial statements.

Identify and assess the risks of material misstatement of the standalone financial statements,
whether due to fraud or error, design and perform audit procedures responsive to those risks,

opinion. The risk of not detecting a material misstatement resulting from fraud is higher than
for one resulting from error, as fraud may involve collusion, forgery, intentional omissions,
misrepresentations, or the override of internal control.

• Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.

- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Company's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the standalone financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Company to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the standalone financial statements, including the disclosures, and whether the standalone financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

Materiality is the magnitude of misstatements in the standalone financial statements that, individually or in aggregate, makes it probable that the economic decisions of a reasonably knowledgeable user of the financial statements may be influenced. We consider quantitative materiality and qualitative factors in (i) planning the scope of our audit work and in evaluating the results of our work; and (ii) to evaluate the effect of any identified misstatements in the financial statements.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

### Report on Other Legal and Regulatory Requirements

- 1. As required by Section 143(3) of the Act, based on our audit we report that:
- a) We have sought and obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purposes of our audit.
- b) In our opinion, proper books of account as required by law have been kept by the Company so far as it appears from our examination of those books.

c) The Balance Sheet, the Statement of Income and Expenditure and the Statement of Cash Flow dealt with by this Report are in agreement with the relevant books of account.

- d) In our opinion, the aforesaid financial statements comply with the accounting standards specified under section 133 of the Act, read with rule 7 of the Companies (Accounts) Rules, 2014;
- e) On the basis of the written representations received from the Members of Committee of Administration as on March 31, 2022 taken on record by the Committee of Administration, none of the Members of Committee of Administration is disqualified as on March 31, 2022 from being appointed as Member of Committee of Administration in terms of Section 164 (2) of the Act.
- f) As this company is registered as Company Limited by Guarantee under Companies Act and under section 12A of Income Tax Act, 1961, the reporting requirement on the Companies (Auditor's Report) Order, 2016 issued by the Central Government in terms of Section 143(11) of the Companies Act 2013 and internal financial controls under section 143(3)(i) of Companies Act 2013 is not applicable as per MCA Notification.
- g) With respect to the other matters to be included in the Auditor's Report in accordance with Rule 11 of the Companies (Audit and Auditors) Rules, 2014, as amended in our opinion and to the best of our information and according to the explanations given to us:
- The Company has disclosed the impact of pending litigations on its financial position in its standalone financial statements.
- ii. The Company has made provision, as required under the applicable law or accounting standards, for material foreseeable losses, if any.

#### **NOTES ON ACCOUNTS**

# 1. Corporate Information

**HANDLOOM EXPORT PROMOTION COUNCIL** is a Section 25 Company domiciled in India and incorporated under the Companies Act, 1956-Section 8 of Companies Act 2013. The Company is engaged in the business of support, protect, maintain, increase and promote the export of Indian handloom fabrics.

# 2. Significant Accounting Policies:

### 2.01. Basis of preparation

These financial statements have been prepared in accordance with the Generally Accepted Accounting Principles in India, on the basis of going concern under the historical cost convention and also on accrual basis. These financial statements comply, in all material aspects, with the provisions of the Companies Act, 2013 (to the extent notified) read with the rule 7 of the Companies (Accounts) Rules 2014.

All assets and liabilities have been classified as current or non-current as per the Company's normal operating cycle and other criteria set out in the Schedule III to the Companies Act, 2013. Based on the nature of products and the time between the acquisition of assets for processing and their realization in cash and cash equivalents, the Company has ascertained its operating cycle as less than 12 months for the purpose of current – noncurrent classification of assets and liabilities.

The accounting policies adopted in the preparation of financial statements are consistent with those of previous year.

#### 2.02 Use of Estimates

The preparation of financial statements in conformity with Indian GAAP requires the management to make judgments, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities and the disclosure of contingent liabilities, as at the date of financial statements and reported amounts of revenue and expenses during the reporting period. Such estimates are on reasonable and prudent basis taking into account all available information; actual results could differ from estimates. Differences on account of revision of estimates, actual outcome and existing estimates are recognised prospectively once results are known/ materialized in accordance with the requirements of the respective accounting standard, as may be applicable.

### 2.03 Property, Plant & Equipment

Property, Plant & Equipment is stated at cost, net of accumulated depreciation and accumulated impairment losses or gains, if any. The cost comprises purchase price, non-refundable taxes, borrowing costs (if capitalization criteria are met) and directly attributable cost of bringing the asset to its present location and condition for the intended use. Any trade discounts and rebates are deducted in arriving at the purchase price.

Subsequent expenditure related to an item of fixed asset is added to its book value only if it increases the future benefits from the existing asset beyond its previously assessed standard of performance. All other expenses on existing fixed assets, including day-to-day repair and maintenance expenditure and cost of replacing parts, are charged to the statement of profit and loss for the period during which such expenses are incurred.

Gains or losses arising from derecognition of fixed assets are measured as the difference between the net disposal proceeds and the carrying amount of the asset and are recognized in the statement of profit and loss when the asset is derecognized.

### 2.04 Depreciation on Tangible Fixed Assets

Depreciation on tangible fixed assets is provided on written down value method, at the rates and manner prescribed in part C of Schedule II to the Companies Act, 2013.

### 2.05 Segment Reporting:

The company is principally engaged in the business of providing services to its members which is considered to be the only reportable segment as per the Accounting Standard 17 "Segment Reporting" issued under the Companies Accounting Standard Rule 2006. As the company operates only in one geographical segment, disclosure under geographical segment is not applicable.

### 2.06 Revenue recognition

Revenue is recognized to the extent that it is probable that the economic benefits will flow to the Company and the revenue can be reliably measured. The following specific recognition criteria must also be met before revenue is recognized.

- (I) Revenue from operations:
  - The revenue from the members and Grant received is recognized on receipt basis.
- (ii) OTHER INCOME:

Revenue is recognized with respect to other income on accrual basis. Amenities Receipts is recognized on receipt basis.

### 2.07 Employee Benefits:

a. Defined Benefit/contribution plan:

The company operates a defined benefit plan for its employees i.e. Gratuity Liability covering all the employees. Provision for Gratuity is made on the norms of the Company on undiscounted basis. The Provision for Gratuity has not transferred to the Gratuity Trust maintained by the Company.

Company contribution to Provident Fund are determined under the relevant schemes and or statute and charged to the statement of Profit & Loss in the period when the contributions are due.

b. Short Term Employee Benefits:

All employee benefits payable wholly with in twelve months of rendering services are classified as short term employee benefits. Benefits such as salaries, bonus Ex-gratia, leave travel allowance, reimbursement of medical expenses are recognized in the period in which the employee renders the related services.

# 2.08 Income tax:

The current tax has not been determined on income for the year chargeable to tax since the

Provisions are not discounted to their present value and are determined based on the best estimate required to settle the obligation at the reporting date. These estimates are reviewed at each reporting date and adjusted to reflect the current best estimates.

Provisions involving substantial degree of estimation in measurement are recognized when there is a present obligation as a result of past events and it is probable that there will be an outflow of resources.
